The Promoter

How to Enter

- 2. The competition will run from 10:00 on 6 September (the **Opening Date**) and will close on 12am 28 February 2023 (the **Closing Date**) inclusive. Entries received after the Closing Date are automatically disqualified and will not be accepted.
- 3. There is no entry fee and no purchase necessary to enter this competition.
- 4.
