### Tutor CPD update

- The Level 4 referee programme had been worked on and the scheme of work was close to being finalised. The syllabus document was also being updated.
- The Level 3 referee programme will be revamped once the Level 4 programme has been completed and launched.
- Table officiating course would also be updated so there is consistency across both disciplines.
