- New club enrolment letter;
- Parents' work certificate/ residence permit (if the purpose of the transfer is due to parents' work/ relocation)

Once the above is complete and the additional information provided Basketball England will contact the Federation of Origin to seek their agreement of this request for International Clearance for an Under 18 Player.

Please note FIBA may request additional information in order to make a decision on this case.
