Where not specified in the question, A1 - A5 are the players on the playing court from the offensive team, A6 - A12 are the substitutes or excluded players from the offensive team. B1 - B5 are the players on the playing court from the defensive team, B6 - B12 are the substitutes or excluded players from the defensive team. Questions are based on OBR 2024 v1.0a, OBRI 2024 v1.0a, IOT Manual v2.5 and FIBA Statisticians Manual 2024.
